
Join Us for an Open House on October 19th



New EMV Debit and Credit Cards Coming Soon

To provide you with maximum payment card security, KCFCU has begun the process of switching out all of our Visa Credit Cards and Visa Check Cards to new EMV chip-embedded payment cards. If your current card does not have an EMV chip, you will soon receive a replacement card in the mail. Once you receive your new EMV card, destroy your mag stripe card.

Unlike magnetic strips, the combination of the EMV chip and your PIN makes it virtually impossible to counterfeit.

Important Reminder for Checking Accounts Opened Before February 2017

If you received a letter reminding you to update your checking account number for automatic debit/payments or direct deposit transactions, please be sure to provide

your updated account number to your debiting/ depositing companies. <u>If you did not receive a</u> <u>reminder letter, or you have already provided</u> <u>updated account numbers to the appropriate</u> <u>companies, no further action is needed.</u>

Fighting Back Against Fraud: Avoid Sharing Sensitive Information on Social Media Sites

Identity thieves are tireless when it comes to finding ways to locate sensitive information about you. These efforts have now spread to social media sites.

Social media has become an integral part of many of our lives, but we must exercise caution. Have you seen posts between friends with question strings like: What was your first car? Who was your favorite teacher? Who was your best friend in high school? While these seem like innocent questions, they are common security questions that people must answer when they forget passwords for Online Banking.

Beware. Criminals are harvesting this information to gain access to consumer accounts. Be vigilant and safeguard sensitive information on social media sites!



Do You Have an "Inactive Account?"

Deposit accounts with no activity for one year get flagged as "inactive" and will be assessed a \$5 fee, if not activated in the following quarter. Accounts that stay "inactive" for multiple years could be closed, with the funds turned over to the State. Don't let this happen to you.

If you receive an "Inactive Account" notice, you must respond to the notice in writing as soon as possible. Make sure KCFCU has your correct contact information on file, so that we may reach you promptly with any important account alerts.
