Fraud Alert Series: What Is "Credit Card Skimming?"

Credit card skimming is a sneaky, high-tech crime in which thieves place a device that fits over existing credit cards readers in ATMs, gas station pumps and other point of sale (POS) sites. The skimmer device is capable of capturing account information stored on the magnetic strip.

Once the criminals have skimmed your account information, they often use it to clone an illegal copy of your card, which can then be used for a variety of fraudulent purchases. Here's how you can protect card and account information:

- Avoid small ATMs in liquor stores or convenience stores that are not linked to reputable networks, such as CO-OP® or Star® System
- Beware of "keypad overlays" that don't match the POS terminal components
- Look for extra plastic pieces that stick out or appear out of place

If a POS card reader looks loose or tampered with, move to a different machine. It's better to be safe than to have your account information skimmed! For more tips on fraud prevention, visit our website at **www.kcfcu.org** and click the "Resources" menu tab.
